Land for Wildlife began in Victoria in 1981 to help bring back wildlife to farms. Since then, the program has expanded across Australia to support landholders in managing their properties for nature conservation.

Land for Wildlife commenced in Queensland in 1998 and is currently coordinated by various Local Governments and Natural Resource Management Groups. As of July 2012, there are currently over 3500 Land for Wildlife properties in South East Queensland managing over 53,000 hectares of land for nature conservation.

What is Land for Wildlife?

Land for Wildlife is a voluntary program that helps landholders provide habitat for wildlife on their properties. The program is free.

Land for Wildlife offers advice on:

- ❖ native plants
- ❖ wildlife
- ❖ weed identification and control
- ❖ revegetation and natural regeneration
- ❖ incentives and grants
- ❖ integrating nature conservation with grazing and other land management activities.

Land for Wildlife provides:

- ❖ one-on-one property visits
- ❖ individualised property advice
- ❖ maps of your property
- ❖ field days and workshops
- ❖ newsletters
- ❖ opportunities to meet other like-minded landholders.

The iconic Land for Wildlife sign acknowledges the conservation efforts of our registered members.

Does my property qualify?

Land for Wildlife welcomes landholders who:

- manage all or part of their property for nature conservation
- integrate nature conservation with other land uses such as agriculture, grazing or tourism
- have a property with at least 1 hectare of native vegetation (exceptions may apply).

Neighbouring properties may join together and apply for group registration.

Land for Wildlife registration does not alter the legal status of a property, convey the right of public access, nor represent an official wildlife sanctuary.



Why join?

Together, Land for Wildlife members can:

- ❖ learn about native plants, wildlife and ecosystems
- ❖ restore degraded lands
- ❖ identify and reduce weeds
- ❖ control pest animals
- ❖ create wildlife corridors
- ❖ improve water quality in our creeks and rivers
- ❖ help our threatened species
- ❖ inspire each other.
